### **SUPPLEMENT #1 First Presidency**

“The simplest statement we know of is the statement of the Lord himself, namely, that the members of the Church should pay ‘one-tenth of all their interest annually,’ which is understood to mean income. No one is justified in making any other statement than this”

(First Presidency letter, 19 Mar. 1970).

#### **President Joseph Fielding Smith**

“It is remarkable how many excuses can be made and interpretations given as to what constitutes the tenth. ... It is written, however, that as we measure it shall be measured to us again. If we are stingy with the Lord, he may be stingy with us, or in other words, withhold his blessings”

(*Church History and Modern Revelation*, [1953], 2:92).

### **SUPPLEMENT #2 Elder Dallin H. Oaks**

“During World War II, my widowed mother supported her three young children on a schoolteacher’s salary that was meager. When I became conscious that we went without some desirable things because we didn’t have enough money, I asked my mother why she paid so much of her salary as tithing. I have never forgotten her explanation: ‘Dallin, there might be some people who can get along without paying tithing, but we can’t. The Lord has chosen to take your father and leave me to raise you children. I cannot do that without the blessings of the Lord, and I obtain those blessings by paying an honest tithing. When I pay my tithing, I have the Lord’s promise that he will bless us, and we must have those blessings if we are to get along’ ”

(General Conference, Apr. 1994, 43–44; or *Ensign*, May 1994, 33).

### **SUPPLEMENT #3 Elder Joseph B. Wirthlin**
